

**TIDDINGTON WITH ALBURY PARISH COUNCIL**  
**Monthly Meeting**  
**Monday 18 May 2009, following the Annual Parish Meeting – at Tiddington Village Hall**

**MINUTES**

1. **Present:** Mr J Nowell-Smith (Chairman and District Councillor), Mrs E Horne, Mrs Z Knight, Mr K Field, Mr B Price, Mr D Turner (County Councillor), Mr K Poyser (clerk) and one member of the public.
2. **Apologies:** None.
3. **Declarations of interest:** None from Councillors, but the Clerk mentioned that the planning application to be considered in respect of Rosewood, Ickford Road, Tiddington was for his wife's property.
4. **Approval of previously circulated minutes**  
The minutes were approved and signed, subject to a minor amendment.
5. **Matters arising from previous minutes**
  - a. Affordable Housing, Station Yard – Brian Price said that he had spoken to a number of people in the village who had had letters asking if they knew of possible applicants for affordable housing and he was concerned that this seemed somewhat random. Could we see a copy of the letter? Clerk to contact OCHA to determine facts. Posters have been received by Clerk and are on display in village. Also to be in Newsletter.
  - b. Drainage/ditching – The latest information is that the work is to be done by Oxfordshire Highways during period June-July, following survey work carried out.
  - c. The sign in Ickford Road re bridge restriction – Peter Ronald from Oxfordshire Highways has been to have a look at the sign and says that he agrees that another sign is needed at the junction with the A418. He is putting the work in hand.
  - d. Sandy Lane / Draycot corner – Peter Ronald informed Clerk that the matter was progressing, albeit slowly. Another inspection to be undertaken. There seems to be a problem with finding the identity of the owner of the land on the Milton Common side of the railway bridge.
  - e. Vacancy on Parish Council – Two possible candidates have come forward and were discussed. Left with Chairman to have a word with preferred applicant.
